Second, the governing body's procedures were clarified to allow official communications to occur electronically. Third, the bylaws relating to the nonvoting membership were changed: to make membership a 1-year term, although renewable; to remove the requirement of an annual meeting, although authorizing members to attend the spring Board of Directors meeting; and to remove the requirement of a quorum for any membership meeting.
